Hon'ble Prime Minister Sheikh Hasina opens first ever underwater tunnel in Bangladesh

The port city Chattogram witnessed country's historic entry into a new era of connectivity as Hon'ble Prime Minister Sheikh Hasina opened the much-awaited underwater expressway tunnel, first of its kind in South Asia, under the river Karnaphuli on 28 October 2023.

The Premier unveiled the plaque of the "Bangabandhu Sheikh Mujibur Rahman Tunnel" at Patenga on the north bank of Karnaphuli connecting city's Patenga with Anwara upazila.

Earlier in a message, the Hon'ble Prime Minister termed the inauguration of the tunnel as a glorious and memorable day for Bangladesh.

"This tunnel will play a groundbreaking role in the development of the communication system of the south-eastern part of the country through developing a major link to the Asian highway network. It will also help in reduction of traffic congestion in Chattogram city, development of the industry sector and tourism industry in the Anwara area. It will help transportation of goods to the Chattogram port and the proposed Matarbari deep sea port," she said. The tunnel has taken the country one step further in the journey towards building Smart Bangladesh by introducing a new level of advanced technology in the road communication system of the region, she added.

The tunnel including approach road was opened to vehicles from 30 October 2023. In terms of connecting two regions of the country, the tunnel is the second "dream scheme" in road transport sector after the Padma Bridge. The tunnel has been built following the "One



City Two Towns" model like Shanghai in China. It would connect the proposed Asian Highway with Dhaka-Chattogram-Cox's Bazar Highway by reducing distance by 40km.

According to the officials, over 17,000 vehicles would be able to use the tunnel on a daily basis equating to some 7.6 million vehicles a year. The tunnel would help increase the country's annual GDP growth by 0.166 percent.

Key infrastructures inaugurated by the Hon'ble Prime Minister Sheikh Hasina in recent times:

fulfilling her promise to transform Bangladesh into a developed country by 2041, Hon'ble Prime Minister Sheikh Hasina inaugurated the following key infrastructures in recent times:

- Inaugurated the Matarbari deep seaport's 14.3-kilometre-long artificial navigation channel on 11 November 2023, expected to be the economic life line of the country.
- Inaugurated the 12.24 km Akhaura-Agartala cross-border rail link on 01 November 2023, jointly with her Indian counterpart Mr. Narendra Modi hoping to foster possibilities in trade, business, tourism and people to people contact. At the same programme, they also jointly inaugurated development projects, two more Khulna-Mongla Port Rail Line; and Unit - II of the Maitree Super Thermal Power Plant.
- Inaugurated record 150 bridges in 39 districts of eight divisions in a single day on 19 October 2023, giving a further boost to the country's road connectivity.
- Inaugurated the 82km Dhaka to Bhanga section rail link that connects Dhaka and Jashore through the Padma Bridge on 10 October 2023.

- Inaugurated the iconic third terminal of the Shahjalal International Airport (HSIA) in the capital on 07 October 2023, bringing a epoch-making change to the country's aviation sector aiming at providing world class passenger services and security.
- Inaugurated the 11.5 km Hazrat Shahjalal International Airport-Farmgate section of Elevated much-awaited Dhaka Expressway on 02 September 2023 by unveiling the inaugural plaque at the Old Trade Fair Ground at Sher-e-Bangla Nagar.
- Inaugurated the country's first-ever metro rail on 28 December 2022 and the extended link of it from Agargaon to Motijheel on 04 2023. On the opening November ceremony, Prime Minister said that another feather has been added to the crown of Bangladesh's development with the opening of its first-ever metro rail, vowing to build a prosperous 'Smart Bangladesh' by 2041.

- Visited Belgium to attend the 'Global Gateway Forum' held on 25-26 October 2023 in Brussels, capital of Belgium at the invitation of the European Commission (EC) President Ursula von der Leyen.
- Visited New Delhi to attend the G20 Summit held during 08-10 September 2023 at the invitation of Indian Prime Minister Mr. Narendra Modi.



- Attended the 78th session of the United Nations General Assembly (UNGA) held in New York during 17-22 September 2023. In her address delivered to the UNGA session, Prime Minister Sheikh Hasina called upon the global leaders to work in unison for peace, welfare of mankind and prosperity by shunning the path of war and confrontation.
- Paid an official visit to Japan from 25 to 28 April 2023 on the first leg of her tri-nation visit to Japan, the USA and the UK. She and her Japanese counterpart witnessed the exchange of eight instruments, mostly Memorandums of Cooperation (MoC) signed between Dhaka and Tokyo to boost cooperation in the areas of customs matters, agriculture, information and communication technology (ICT) including cyber-security, industry upgradation, defense, intellectual property, ship recycling and metro rail.

Awarding Ceremony of "National Export Trophy 2020-2021" held

The National Export Trophy 2020-2021 Awarding Ceremony was held on 8 November 2023 at Osmani Memorial Auditorium. A number of 73 exporters have been awarded the National Export Trophy at the ceremony. Mr. Tipu Munshi, MP, Honorable Minister, Ministry of Commerce handed over the trophies to the awardees. The ceremony was jointly organized by the Ministry of Commerce

and Export Promotion Bureau (EPB).

The Minister called upon all businessmen to work together to achieve the target of export income of one hundred billion dollars by 2030. Instead of relying only on the garment industry, products should be diversified for export. The key purpose of awarding this trophy is to create enthusiasm and fair competition among the exporters, leading industrialists and businessmen who have achieved success in export business and trade. This trophy will further motivate the awardees and spur others to work on new ventures.

Mr. Tapan Kanti Ghosh, Senior Secretary, Ministry of Commerce presided over the programme and Mr. Mahbubul Alam, President, Federation of Bangladesh Chambers of Commerce and Industry (FBCCI) were present as the Special Guest. Mr. A.H.M. Ahsan, Vice Chairman, EPB delivered the welcome remarks.

Engagements of Honorable Commerce Minister in recent times:

- The Honorable Commerce Minister Mr. Tipu Munshi, MP and Mexico's Secretary of the Economy, Ms. Raquel Buenrostro have expressed their commitment to take the economic relations of the two countries to a new height. A bilateral meeting was held in Mexico on 25 September 2023. This was the first such top-level meeting between the two countries in nearly five decades.
- Attended the Group of Twenty (G-20) Trade and Investment Minister's Meeting from 24 to 25 August 2023 in Jaipur, India. Addressing the meeting, he called upon the G-20 members to support countries including Bangladesh, in continuing the Duty-Free Quota Free (DFQF) market facility after her graduation in 2026.



- Sought support from the Commonwealth Ministers for continuation of existing Duty-Free and Quota-Free (DFQF) market access for Bangladesh after her graduation from the status of a Least Developed Country (LDC). The Minister made the request at the Commonwealth Trade Ministers' meeting held from 05-06 June 2023 at Marlborough House in London.
- Bangladesh and Bhutan inked an "Agreement on movement of traffic-in-transit and protocol" on 23 March 2023 in Thimpu, the capital of Bhutan, to strengthen bilateral trade relation and simplify transaction procedure between the two countries. Hon'ble Commerce Minister of Bangladesh Mr. Tipu Munshi, MP and Minister for Industry, Commerce and Employment of Bhutan Mr. Lyonpo Karma Dorji signed the agreement on behalf of the respective sides.
- Paid a two-day visit to India during 22-23 December 2022. The Minister's two-day trip hinged upon negotiations with his Indian counterpart Shri Piyush Goyal, Commerce and Industry Minister in Delhi India-Bangladesh proposed the Comprehensive Economic Partnership Agreement (CEPA).

Senior Secretary visited Japan for promoting bilateral economic relations

The key objective of the Ministry of Commerce (MoC): Contribute to the nation's economic development through creation of a business friendly environment, simplification of export and import trading, rationalize tariff rate, promoting the eqitable interests of domestic industries, stabilizing the prices of daily necessities and enhancing external trade.

Japan is one of the most important trading partners of Bangladesh. For bolstering the bilateral economic relations between Bangladesh and Japan, the Ministry of Foreign Affairs of Japan invited Mr. Tapan Kanti Ghosh, Senior Secretary, Ministry of Commerce, Government of the People's Republic of Bangladesh to visit Japan from 21 to 28 September 2023. During the visit, Mr. Ghosh had a series of meeting with the officials of the Ministry of Foreign Affairs, Ministry of Economy, Trade and Industry, Japan International Cooperation Agency (JICA) and Japan External Trade Organization (JETRO). He also met the representatives of various Academia and Think Tanks. The discussions centered on improving bilateral relations especially in trade and economic cooperation between the countries. two During discussions, he had the opportunity to gather information regarding Japan's conclusion of 21 Economic Partnership Agreements (EPAs) with 24 countries and other related issues. It may be that mentioned initiatives have been undertaken for assessing the prospect of signing an EPA with Japan for increasing trade, investment and economic cooperation. A Joint Study Group (JSG) has already been formed between the two countries to conduct a joint feasibility study for the finalization of the EPA. The JSG has already completed their third round of meetings on September 2023.



In recent times Senior Secretary of the MoC attended the following key events:

- The government of Bangladesh has set an export target of \$72 billion for the fiscal year 2023-24. Out of this export target, the target for goods and services export have been set at \$62 billion and \$10 billion respectively. The Honorable Commerce Minister Mr. Tipu Munshi, MP has announced the target at the conference room of the Ministry of Commerce (MoC), Dhaka on 12 July 2023. Mr. Tapan Kanti Ghosh, Senior Secretary, MoC moderated the meeting.
- Bangladesh Tea Board organized a colourful programme on the occasion of '3rd National Tea Day' at Sreemangal in Moulvibazar on 04 June 2023. The Honorable Commerce Minister Mr. Tipu Munshi, MP was present on the occasion as the Chief Guest. The programme was presided over by Mr. Tapan Kanti Ghosh, Senior Secretary, Ministry of Commerce.
- The second Bangladesh-UK Trade and Investment Dialogue was held in Dhaka on 19 February 2023. The Government of Bangladesh was represented by Mr. Tapan Kanti Ghosh, Senior Secretary, MoC while His Majesty's Trade Commissioner for South Asia, Mr. Alan Gemmell OBE, led the UK delegation. The British High Commissioner, Mr. Robert Chatterton Dickson was also present.
- Bangladesh and Singapore have signed a Memorandum of Cooperation to set a stage for negotiation on a Free Trade Agreement (FTA) and explored potential for trade and investment opportunities between the two

countries on 16 November 2022. The Honorable Commerce Minister Mr. Tipu Munshi, MP and Singapore's Minister-incharge of Trade Relations Mr. S. Iswaran signed the Memorandum of Cooperation on Trade and Investment (MCTI) on behalf of the respective governments. The signing ceremony was moderated by Mr. Tapan Kanti Ghosh, Senior Secretary, Ministry of Commerce.

The Government of Bangladesh working to control inflation: Hon'ble Finance Minister

"The World Bank and the International Monetary Fund (IMF) said that the the economy of Bangladesh is on the right track. Currently, our foreign exchange reserves is US\$20 to US\$22 billion," he added. Hon'ble Finance Minister expressed hope that inflation would decrease in the coming days.

World Bank to give \$1.1b for 5 projects

The WB said the five financing projects would help the country to achieve resilient and inclusive growth by improving early childhood development, secondary education, riverbank protection and navigability, urban primary health, and gas distribution efficiency. The credit will be provided from the World Bank's International Development Association (IDA).

BFTI is conducting a study to gauge the impacts of Padma multipurpose bridge on the foreign trade of Bangladesh

Bangladesh Foreign Trade Institute (BFTI) is conducting a study titled 'Impact of Padma Multipurpose Bridge on the Foreign Trade of Bangladesh' to explore, investigate understand the underlying impacts of the Padma Multipurpose Bridge on the foreign trade of Bangladesh for the first time in the country. The objective of this study is to unveil the impacts of the Padma Multipurpose Bridge on export-import, trade logistics, regional connectivity and other trade-related aspects. The study also attempts to advocate some recommendations for policy enhancing investment and utilizing the bridge's connectivity for trade and economic growth.

BFTI is conducting a study titled "Bangladesh Trade and **Investment** Study: Market Opportunities and Trade Barriers"

Tetra Tech International Development Pty Ltd. (Tetra Tech) in conjunction with the Bangladesh Foreign Trade Institute (BFTI) and Institute for International Trade (IIT), the University of Adelaide, Australia is conducting research titled

"Bangladesh Trade and Investment Study: Market Opportunities and Trade Barriers."The study is funded by the Department of Foreign Affairs and Trade (DFAT) of the Australian Government. It is worth mentioning that the diplomatic engagements and cooperation between Australia and Bangladesh have been strengthened over the years. The signing of a Investment Trade Framework and Arrangement (TIFA) in 2021 between the two further enhanced investment prospects.

The objective of this study encompasses a meticulous examination of market opportunities and limitations pertinent to enterprises Australian and exporters. Furthermore, the study endeavors to formulate recommendations relevant to strategies for increased trade and investment activities between Bangladesh and Australia.

It also aims to identify existing trade constraints and propose potential recommendations for resolving constraints. The sectors under the study include (i) Agriculture, (ii) Fisheries and Livestock, (iii) Energy and Minerals, (iv) Air Connectivity and (v) Vocational Education. Additionally, several other major sectors, including (i) Ready-Made Garments, (ii) Information Technology, (iii) Light Engineering, (iv) Leather Goods, and (v) Footwear, are also being scrutinized in this study.

The objectives of this study are to identify the trends of the global fashion industry in terms of international trade and fashion consumption pattern/consumer preference, analyze the RMG export trend of Bangladesh, understand the gap between global fashion trends and Bangladesh's existing export trends, gain insights on the challenges and prospects of Bangladesh's RMG sector in the context of the global fashion industry and generate recommendations for increasing contribution of Bangladesh's RMG sector to the global fashion industry and sustaining the country's RMG export growth trajectory.

A Framework Document on the WTO Ministerial Conferences (MCs) Outcomes and Agreements and Key Doable Actions for Bangladesh

WTO MCs Outcomes and Agreements. Since the provisions of WTO are crucial for the country's trade development and Bangladesh is graduating into a developing country, WTO rules, agreements and decisions should be thoroughly examined to explore more trade opportunities.

The rationale behind this framework document is to delineate the potential scope and critical aspects of the major WTO MCs Outcomes, Agreements and Key Doable Actions for Bangladesh which are instrumental in international trade and determine the areas of intervention. The document's primary objective is to provide an understanding of how these 12 WTO MCs Outcomes, Agreements affect economy, trade policies and overall development and find key doable actions for Bangladesh.

By meticulously analyzing the specific provisions and arrangements within the WTO MCs Outcomes and Agreements, the document aims to evaluate their potential benefits, challenges and relevance to Bangladesh's national interests. Furthermore, it seeks to identify implementation gaps or areas of concern while exploring potential strategies to maximize benefits and minimize adverse consequences for Bangladesh.

The findings of this document will significantly contribute to augmenting knowledge related to the WTO MCs Outcomes and Agreements. It will serve as a valuable resource for policymakers, researchers and stakeholders in Bangladesh offering insights and recommendations to develop the country's engagement with the WTO and optimize the benefits derived from these WTO MCs Outcomes, Agreements and find key doable actions for Bangladesh.



BFTI is implementing a project on "Developing Export Competitiveness of Potential Halal Products of Bangladesh"

BFTI is implementing a project of Ministry of Commerce on "Developing Export Competitiveness of Potential Halal Products of Bangladesh". The project is funded by the Standing Committee for Economic and Commercial Cooperation (COMCEC) of Organization of Islamic Cooperation (OIC). The project has been selected and awarded by the COMCEC Coordination Office (CCO) in response to the 10th call for project proposal under the COMCEC Project Funding. The contract of the said project has been signed by the Ministry of Commerce, Bangladesh and Development and Investment Bank of Turkiye. The objective of the project is to improve the capacity of the officials from both public and private sector related to halal certification.

Under this project, a delegation of 5 officials led by Dr. Md. Jafar Uddin, CEO, BFTI, Dr. Saif Uddin Ahammad, Joint Secretary, MoC, Ms. Mahbuba Khatoon Minu, Deputy Secretary, MoC, Mr. Md. Julfikar Islam, Research Manager, BFTI and Mr. SM Abu Sayed, Assistant Director, Bangladesh Standards & Testing Institution visited to Istanbul, Turkiye held from 23 October 2023 to 27 October 2023. The objective of the study visit was to gather the first-hand experience of the successful implementation of SMIIC/OIC Standards prepared and published by Standards and

Metrology Institute for Islamic Countries (SMIIC) and the halal accreditation and certification services provided by the national bodies of Turkiye, Halal Accreditation Agency (HAK) and Turkish Standards Institution (TSE).

On the first day (24 October 2023), The team participated in an International Conference on Global Recognition of Halal Certificates organized by HAK at Gonen Hotel, Istanbul, Türkiye. On the same day, the study team also had a meeting with a team of HAK led by Zafer SOYLU, Chairman of the Board of Directors, HAK. The team also visited SMIIC office to learn about its areas of work and activities on Halal Standards. Afterwards, the team visited the Turkish Standards Institution (TSE) quality campus to witness the quality testing procedures and laboratory facilities.

The concerned stakeholders need to acquire required knowledge and strategies to make the negotiation fruitful. It is also essential for the negotiations to have a sound knowledge of WTO-related agreements".

The formation of an expert pool comprising of experienced government and private sector actors is under consideration. Additionally, he said "In line with the Regional Trade Agreement (RTA) Policy 2022 guidelines, Ministry of Commerce has planned to form a 'Trade Negotiation Structure' with members of various ministries, private institutions, think tanks and academia. He also said that after the LDC graduation in 2026, Bangladesh will not get duty-free benefits in trade. Under the new situation, Bangladesh needs to enter into free trade agreements with other countries and trade alliances. He hoped that this training would be helpful to improve negotiation skills and proper understanding of FTAs." He thanked the Chief Executive Officer of BFTI for organizing such an exceptional and timely training programme.

CEO of BFTI and a Former Senior Secretary of the Ministry of Commerce, Dr. Md Jafar Uddin presided over the programme. Expressing his gratitude to the Chief Guest and other guests, the CEO said, "The presence of the Hon'ble Commerce Minister and Barrister Md. Sameer Sattar, President of DCCI will motivate the trainees." He further said, "BFTI, by imparting training, is striving to enhance business-related knowledge and skills of public and private sector officials. WTO Related News

DDG Zhang calls on LDCs to explore ways for boosting agriculture and services trade

A workshop on least-developed countries (LDCs) and the multilateral trading system was held on 03 November 2023 at the WTO. Speaking at the workshop, Deputy Director- General Xiangchen Zhang said: "We need to keep building on the progress made to support the greater integration of LDCs into global trade."The event provided an

opportunity for WTO members and trade experts to discuss the findings of a new study outlining the participation of LDCs in agriculture and services trade. Entitled "LDCs and the multilateral trading system", the publication stresses that certain governmental trade and non-trade measures could undermine prospects of LDCs' exports.

The discussion brought to the fore that trade support remains essential in strengthening the capacity of LDC service supplying firms. Among the priorities requiring LDC policy makers' particular attention were the need to i) address data gaps, ii) strengthen domestic regulatory frameworks, iii) diversify LDC services export baskets, and iv) boost firms' competitiveness through trade finance and skills upgrading. Speakers also cited regional integration as important for boosting LDCs' services exports.
